GOVERNING BODY STRUCTURE

The Governing Body has sole responsibility for the strategic direction of the College, acting as critical friend and being accountable for its decisions.

The Governing body has agreed to have two standing committees:-

Quality of Provision (QP) To challenge the College progress on key priorities and outcomes as outlined in the College Development Plan, considering relevant data and reports at regular intervals. To consider curriculum matters and ensure the standards of teaching in the College are at their highest. To oversee behaviour and attendance reports and policies including exclusions.

Finance and Resource (FR)

To oversee budget setting and all financial processes within the College, including salaries and performance management outcomes. To ensure health and safety issues are appropriately prioritised and to have an oversight of site issues.

All committees report to the full Governing Body three times per year.
